As a condition of participating in the equine activities Releaser (individually and for his/her executors, assigns, invites and minor children) waives the right to bring Release's administrator, agents, officers, directors, employees, predecessors and succession in-interest and persons or entities in interest with Release from any and all manner of actions, suits, claims for relief, demands, damages and any other obligations, known or unknown, suspected and unsuspected, in law or equity, direct or indirect and whether now or in the future, for any injury or death arising out of or connected in any way with riding, training, boarding, grooming or riding as a passenger upon an equine. If for any reason any provision of this release is determined to be invalid, the remainder shall continue in full force and effect. If I am being furnished an equine, I acknowledge reasonable and prudent efforts have been made to determine my ability to safely ride, train, drive, groom or ride as a passenger upon an equine and to manage the equine furnished. If I am being furnished equipment or tack, I acknowledge it has been reasonably and prudently inspected. This release contained the entire agreement between the parties hereto and the terms of this release are contractual, not a mere recital.
